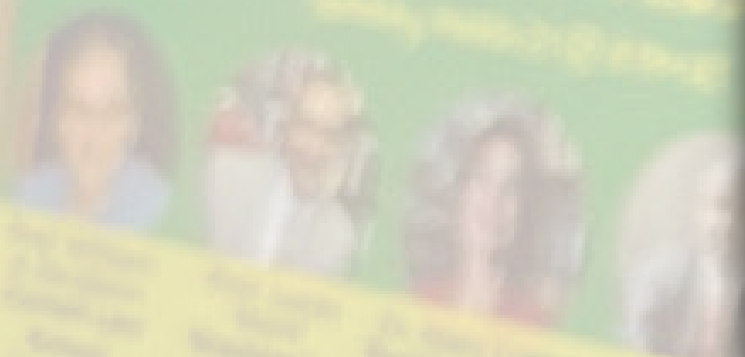

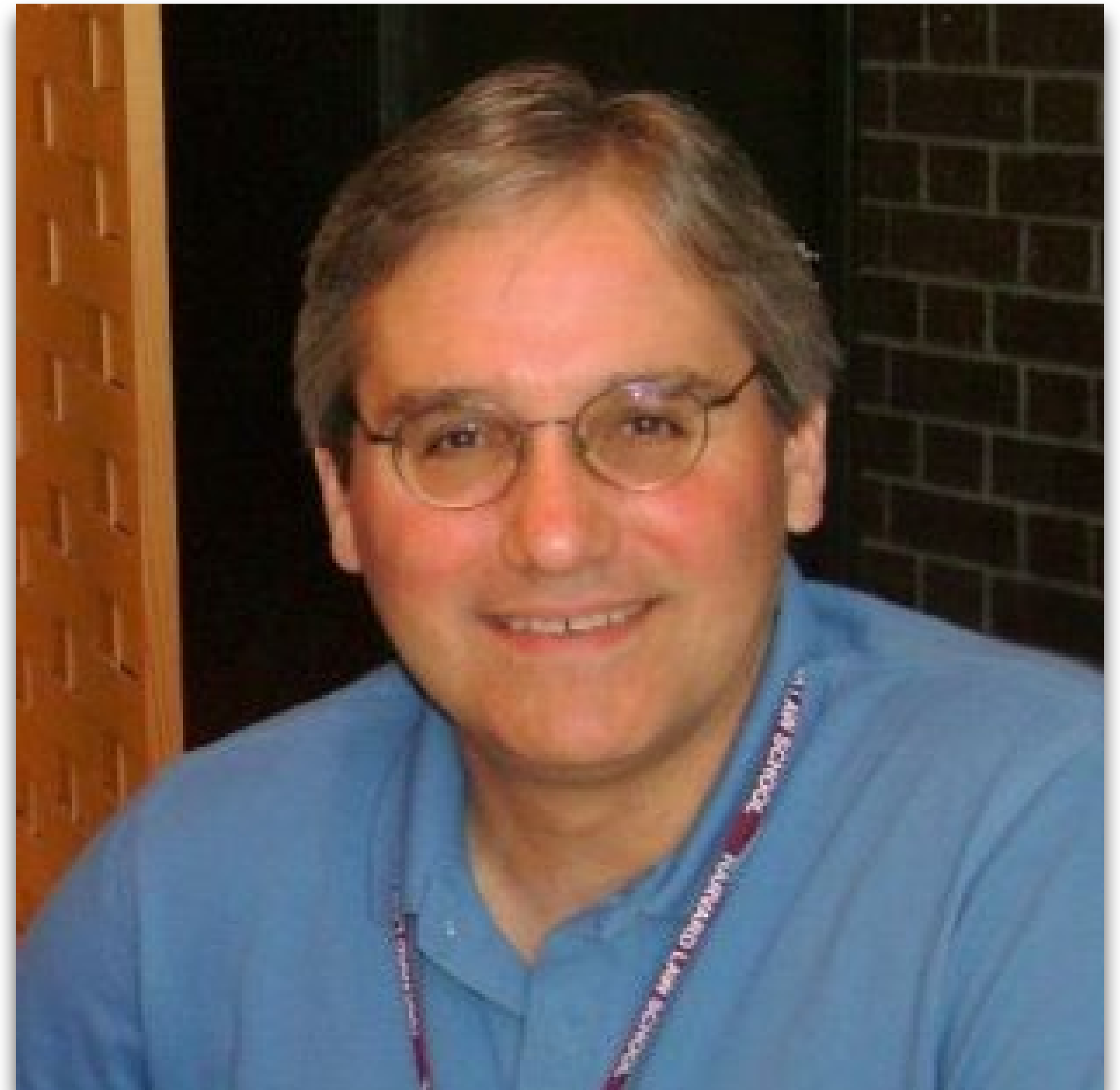

Exclusive coverage from original incident through trial.

AMERICAN STUDIES ASSOCIATION

Exposed American Studies Association boycott of Israel.

Organized grassroots campaign through website, convincing over 250 university presidents to condemn the boycott.

Professor Jacobson publicly challenged 39 Vassar College pro-boycott professors to a debate, and delivered lecture after no faculty agreed to a debate.

EXPOSED TERRORIST RASMEA ODEH IN U.S.

Published extensive research on Rasmea Odeh, on trial
in Detroit for immigration fraud.

Exposed her involvement in a 1969 deadly terror
attack in Israel.

Almost single-handedly reversed public narrative of
Rasmea Odeh from victim to unapologetic killer.





ELIZABETH WARREN

Drove issues relating to background and character in the 2012 Senate race.

Created Elizabeth Warren Wiki research website, elizabethwarrenwiki.org.

Professor Jacobson is a widely-quoted and sought-after authority on Warren's Native American and other controversies.

- Tax-exempt non-profit, IRS 501(c)(3) approval granted March 2018.



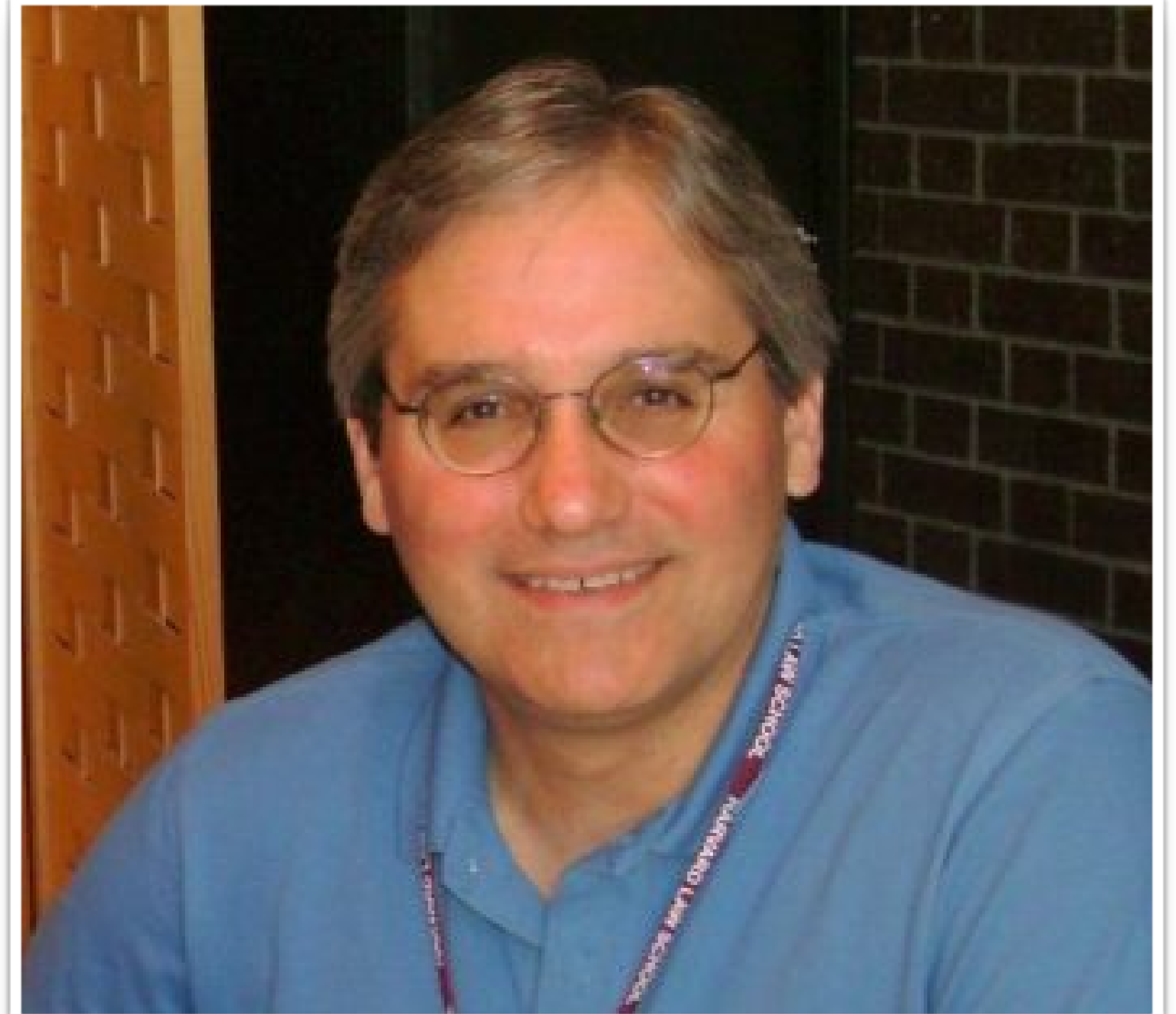
