Due to the extensive and pervasive news coverage of this case and the incidents and events giving rise to this action, as well as the accusations and negative comments from the public atlarge regarding Defendants, Oberlin College and Dr. Raimondo cannot receive a fair and impartial trial in Lorain County. Thus, Defendants respectfully request in the interests of justice that this case be immediately transferred to the Cuyahoga County Court of Common Pleas and that an oral hearing be held so that Defendants can present additional evidence in support of their request to transfer venue.

A Memorandum in Support of this Motion to Transfer Venue is attached hereto and incorporated herein by reference.

INTRODUCTION

This lawsuit stems from a divisive and highly charged event that has impacted the City of Oberlin, Oberlin College, and residents throughout all of Lorain County. On November 9, 2016, an Oberlin College student attempted to shoplift wine and purchase alcohol with a fake ID from Gibson's Bakery. Allyn D. Gibson, a Gibson's Bakery employee who was working at the time, confronted the student and ran after him when he exited the store. Allyn D. Gibson, a white male, then proceeded to initiate a physical bout with the accused shoplifter, a black male, on Oberlin College's campus, as a crowd of students and community members watched. Many who witnessed or later heard about this incident believed that the physical altercation was racially motivated. From their vantage point, a white man chased and assaulted a black man without provocation

and then two female black students intervened to protect the male student. These concerns were heightened when only the black students involved were arrested by the Oberlin Police Department officer who arrived on the scene in response to 911 calls from some of those same witnesses who reported Allyn D. Gibson as the aggressor. In response, students protested outside of Gibson's Bakery in the days following the incident and refused to patronize the store.

Plaintiffs now allege that they have suffered a loss of business as a result of the protests that occurred. They also assert that Oberlin College spearheaded the protests and defamed them by creating and distributing an allegedly defamatory flyer – all of which caused purported financial harm to Gibson's Bakery. Indeed, Plaintiffs' Complaint is fraught with allegations designed to portray themselves as victims wrongfully targeted by Defendants and the protestors when, in fact, many Oberlin students and community members were protesting the physical assault by Allyn D. Gibson on unarmed Oberlin students who did not initiate the physical struggle.

Defendants never acted wrongfully or unlawfully. Indeed, they did not organize or sanction the protests or distribute flyers, and they never targeted or caused any harm to Plaintiffs. Defendants' sole concern was and has at all times been for the safety and well-being of students and the community as the students exercised their right to peaceably protest a perceived wrong. Despite Defendants' lack of involvement in the protests, and their concern for Oberlin College and the Lorain County community, the media coverage within Lorain County of this case and the events giving rise to it has been sensationalized and has not been accurate or impartial.

As a result, the jury pool has been poisoned and Defendants Oberlin College and

Dr. Meredith Raimondo cannot receive a fair and impartial trial in Lorain County, Ohio. Accordingly, Defendants respectfully request that this case be transferred without delay to the Cuyahoga County Court of Common Pleas. They also request an oral hearing in order to present additional evidence in support of their request for a venue transfer.

BACKGROUND

Two daily newspapers circulate within Lorain County: *The (Lorain) Morning Journal* and *The (Elyria) Chronicle-Telegram*. In addition, Lorain County is served by a handful of weekly newspapers, including the *Oberlin News-Tribune*. Each of these newspapers has extensively covered this lawsuit and the surrounding events. In fact, *The Chronicle-Telegram* ranked this lawsuit and the events giving rise to it as the fifthmost impactful news story in Lorain County in 2017.¹ The consequential nature of this lawsuit and related incidents is highlighted by the fact that the top two most critical news stories included national issues such as deportations and the opioid crisis.

The reporting on the events that preceded this lawsuit has also been marred by admitted inaccuracies – inaccuracies that readers have viewed and that Plaintiffs have even wrongfully incorporated into their Complaint. On November 10, 2016, the *Oberlin News-Tribune* reported that Dr. Raimondo circulated literature describing Gibson's Bakery as a "racial establishment" while she "stood with the crowd." Plaintiffs then

adopted this narrative by repeatedly alleging in their Complaint that "Defendants were involved in the preparation, review, copying, dissemination, and publication of the defamatory flyer" and that Dr. Raimondo, in particular, "distributed the flyer to Oberlin College students, faculty, the public and even the media." Compl. ¶¶ 40, 42. After Plaintiffs filed this lawsuit, the newspapers within Lorain County regurgitated the allegations in the Complaint – allegations which are not supported by the facts or evidence. For example, *The Chronicle-Telegram* reported that the "lawsuit alleges Raimondo and other college professors were present and took part in the protests and the dissemination of flyers as well." This is patently false. *The Chronicle-Telegram* even posted a copy of the Complaint on its website, thereby further disseminating to the Lorain County community the inaccurate and unsupported allegations to the public.⁴

The initial reporting of the lawsuit swiftly turned the tide of public opinion within Lorain County against Oberlin College and Dr. Raimondo. Readers of local newspapers forcefully declared how they would rule in any trial. For example, the two daily Lorain County newspapers included these disturbing comments:

- "I hope Gibsons wins this lawsuit";
- "The college, by their breach of contract, has punished Gibsons, . . . have, they punished any of the students involved, or did they just give them a hug?";
- "Gotta go with a Jury Trial. . . Juries can multiply damages";

- "They [Plaintiffs] should have asked for a LOT more";
- "Good!! I hope the owners of the store win and win big-time";
- "Hope they win. . . Take down the Clown College"; and
- "Hey Oberlin open up your wallet and dig deep."

Lost among the rush-to-judgment of these potential jurors was the "revised" article that the *Oberlin News-Tribune* published on November 14, 2016, four days after the initial protest at Gibson's Bakery. In that revision, the *Oberlin News-Tribune* clarified that *students* wrote the literature distributed at the November 10, 2016 protest and that Dr. Raimondo merely provided the flyer to the newspaper in response to an inquiry by a reporter.⁵ In addition, the *Oberlin News-Tribune* made clear that, rather than serving as active participants, Dr. Raimondo "and other college administrators stood by to monitor the protest," according to Scott Wargo, Oberlin's Director of Media Relations.⁶ Despite these corrections, the damage to Oberlin College and Dr. Raimondo was done. Just as bad, the inaccurate and misleading November 10, 2016 *Oberlin News-Tribune* article remains publicly available, with its resulting and on-going prejudice to Oberlin College and Dr. Raimondo.

The initial blast of negative news coverage after the start of the lawsuit has continued to fuel anti-Oberlin rhetoric among the public. On November 16, 2017, *The Chronicle-Telegram* quoted a member of a Lorain County advocacy group as saying

that, based on the news coverage she had read, Oberlin College "is being a bully[.]"

This article – which quoted Plaintiff David Gibson extensively in regard to the current state of his business – led to another flurry of hostile comments about Oberlin College from readers of this local publication.

The concern is not the amount of media coverage or community interest, but rather the lack of balanced views represented in posted comments in the local newspapers that undeniably reflect this conclusion: the jury pool has been biased by initial reporting and opinions expressed upon inaccurate information. Among the 94 comments on this article, most placed all the blame for the Gibsons' predicament squarely on Defendants. Some examples illustrate this point:

- "[T]he college and its administration . . . alone are responsible for this mess. They 'went low' from the beginning."
- "They should be suing for 10 times that amount. Somewhere this type of liberal crap needs to stop."
- "I think the college should be held responsible financially for their behavior in this situation. I really hope this guy takes them to the cleaners."
- "I hope Oberlin College loses everything it has."

In addition, Oberlin College received numerous voicemail messages that further evidence that the jury pool has become tainted. Specifically, the messages revealed that many citizens had improperly determined that Oberlin College was already liable for Plaintiffs' claims:

• "You guys should be ashamed of yourselves. You liberal, radical, disgusting human beings. I'm going to do everything in [my] power to

gather as many people as I can to protest against you. You, you talk about racist. You guys are disgusting. You're despicable. And I'm gonna gather as many people as I can to go out and boycott against you and your campus. You're evil, evil, evil people. You should be ashamed of yourself." (Message received on 12/9/2017)

- "I was figuring I'd get a recording and not an actual human. Not sure if there are any of those there at this college. But I'm calling concerning what was on the internet the other day. You need to get a paycheck but there are other students that have a little higher quality than apparently some of your students that you have now are. The thugs that attempted to do the stealing is [sic] in the wrong and for adult to be leader [sic] of a higher learning institution needs to realize what common sense is and not the black thugs. Thugs are thugs. Get'em out of your college and let students that have some common sense and have some morals and won't make America great can enter your school. It's just ridiculous you backing thugs. I mean there's just no reason why you should do that. They are clearly in the wrong." (Message received on 12/9/2017)
- "I'm calling perhaps hopefully with many other people to express and actually a bit of sadness but certainly dissatisfaction the way Oberlin's administration, faculty and students have treated a business who wanted some justice for theft. I can't imagine any reason the college would support boycotting because someone was called on [sic] for theft of a store." (Message received on 12/9/2017)

These jaded comments are not indicative of a fair and impartial jury pool. Instead, they reflect a populace predisposed to enter a verdict against Defendants without regard to the evidence.

Even today, Oberlin College and Dr. Raimondo remain subject to intense negative media and public scrutiny from among those who would serve as potential jurors at trial. Defendants are unable to receive a fair and impartial trial in Lorain County. As a result, Defendants respectfully request that this action be transferred to Cuyahoga County and that an oral hearing be held so that they can present additional evidence in support of their request for transfer.

LAW AND ARGUMENT

Oberlin College moves for transfer of this action to the Cuyahoga County Court of Common Pleas pursuant to Civ.R. 3(C)(4), which states:

Upon motion of any party or upon its own motion the court may transfer any action to an adjoining county within this state when it appears that a fair and impartial trial cannot be had in the county in which the suit is pending.

Ohio case law has routinely applied Civ.R. 3(C)(4) when a fair and impartial trial cannot be had in the county in which a suit is pending. *See, e.g., State ex rel. Lyons v. Zaleski,* 75 Ohio St.3d 623, 665 N.E.2d 212 (1996) (affirming the trial court did not abuse its discretion in granting motion for change of venue); *State ex. rel Dunbar v. Ham,* 45 Ohio St.2d 112, 341 N.E.2d 594 (1976) (affirming the trial court was permitted by rule to transfer the venue to an adjoining county when it appears that a fair and impartial trial cannot be had in the county in which the suit is pending); *see also State v. Potter,* 64 Ohio App.3d 549, 583 N.E.2d 30 (3rd Dist. 1989) (affirming trial court was not required to make good faith effort to empanel a jury before granting a motion for change of venue); Ohio Const., Art. 1, § 5 (guaranteeing every individual the right to a fair and impartial trial).

Appellate courts have recognized the trial court's broad discretion to transfer cases to appropriate venues pursuant to Civ.R. 3(C). *See McCoy v. Lawther*, 17 Ohio St.3d 37, 38, 476 N.E.2d 1048 (1985) (a trial court's decision to change venue is reviewed on an abuse of discretion basis); *Tracy v. Merrell–Dow Pharmaceuticals, Inc.*, 58 Ohio St.3d 147, 152, 569 N.E.2d 875 (1991) (an abuse of discretion connotes more than an error of law or judgment; it implies that the trial court's attitude was unreasonable, arbitrary, or unconscionable).

The community of Lorain County has been inundated with news articles concerning this lawsuit and the events on which it is based. The extensive media coverage influences and expands the depth and breadth of the prospective jurors' knowledge of what they perceive to be the truth. Undoubtedly, many of these prospective jurors hold opinions about Defendants' purported involvement based solely on media coverage. In fact, the *Oberlin News-Tribune* revised its initial coverage of the November 10, 2016 protests outside Gibson's Bakery to clarify that the "literature" circulated during that protest was written by some students, and not by Oberlin administrators, faculty, or staff. But the false allegation that Oberlin's administrators, faculty or staff led the protests and created the flyer distributed at the demonstrations still serves as the cornerstone of Plaintiffs' Complaint. *See e.g.*, Compl. ¶¶ 34, 35, 40-43, 101-103, 111-112.

When the news media has to run a correction of a widely-reported, inaccurate account of key facts that are at the core in this pending case, ultimately, the damage to Oberlin College and Dr. Raimondo is irreparable. The result: the deprivation of Defendants' right to receive a fair and impartial trial in Lorain County. In contrast, a transfer of venue to adjoining Cuyahoga County will provide a larger pool of potential jurors who have little or no connection to the events giving rise to this suit and who have not already been swayed by news coverage. This will ensure that Oberlin College and Dr. Raimondo are given the opportunity to defend themselves in a jury trial that is free from unfairness and partiality.

In addition, the extensive public comments made following these news stories have likely further tainted the potential jury pool in Lorain County to the point that

Oberlin College and Dr. Raimondo will likely not receive their constitutional right to a fair and impartial trial. A presumption of prejudice is well-established by the community's comments posted in response to these news stories, which represent the beliefs of potential jurors in Lorain County. Commentators went so far as to describe Oberlin College as "an institutional bully to the city and the businesses" and expressed their hope that Oberlin College gets "taken to the cleaners." Further, Dr. Raimondo is accused in comments to these same news articles of "egging on" the protesters, and using school resources to do so, with Oberlin College doing nothing about it.9

Finally, Defendants are sensitive to the long-standing, complex, and at times strained, relationship between the City of Oberlin and the College. Indeed, residents, former students, and current faculty members have commented on the tense feelings that at times exist between the City and the College – a factor separate and apart from this lawsuit and the events that spawned it – which favors Defendants' requested transfer.

This Court has broad discretion in transferring a case to an adjoining county.

Thus, in an effort to alleviate any additional strain between the City and the College, and to avoid further prejudice to Defendants in this action, this case should be transferred to Cuyahoga County.

CONCLUSION

Under Civ. R. 3(C)(4), Defendants Oberlin College and Dr. Meredith Raimondo

respectfully request that this Court immediately transfer this action to the Cuyahoga County Court of Common Pleas. Granting the foregoing Motion will ensure that Oberlin College and Dr. Raimondo receive the fair and impartial trial to which they are entitled and further ensure that they will avoid the severe prejudice of an unfair and partial trial if this suit proceeds in Lorain County. Defendants urge this Court to conduct an oral hearing so that they can present additional supporting evidence on the necessity of granting this Motion. The interests of justice and due process require no less than the requested relief under the exceptional circumstances presented.



5. Gibson's suspects plead guilty; store sues Oberlin College

Although Jonathan Aladin's arrest for trying to steal wine from Gibson's Bakery in Oberlin and the resulting protests happened in November 2016, the fallout from the incident continued to reverberate this year.

A struggle ensued when Aladin was confronted by Allyn Gibson, a son of the store's owner. Gibson chased the student outside and across the street to Tappan Square where two other students began kicking and punching Gibson on the ground.

Days of protests outside the bakery followed with some at Oberlin College calling the bakery racist because the students are black and Allyn Gibson is white.

In August the students pleaded guilty to misdemeanor charges and read statements saying Gibson's actions were not racially motivated, but the owners of the bakery said by that point the damage to its reputation had already hurt its sales.

The bakery has since sued the college, which responded by challenging how Gibson's handled the incident and suspending its business relationship with the store.



'End racial profiling' shouts OC crowd after arrests

"Hold Gibson's accountable" and "Gibson's is racist," chanted a throng cabout 150 Thursday outside the West College Street bakery.

Oberlin College students, bearing signs saying "No justice, no peace" and "End racial profiling," protested for hours and called for a boycott of the 131-year-old business. While they took care not to block the entrance, they did hurl expletives at the few customers who entered.

"This is a racist establishment with a long account of racial profiling and discrimination," said literature provided by OC dean of students Meredith Raimondo, who stood with the crowd.

It alleges bakery owner Allyn Gibson choked a 19-year-old man until others forced him to let go. The account claims Gibson chased the man across College Street and onto Tappan Square, tackling and restraining him until police arrived.

It says the alleged victim and two friends were racially profiled at the scene but does not explain how. Police arrested the three but did not read them their rights, students claimed.

Organizers said the 19-year-old was charged with robbery and his friends were charged with assault. No Oberlin police report had been filed at the time of the protest.

Trey James, a worker at Gibson's, said the 19-year-old was actually 17 and had attempted to shoplift alcohol. He denied the choking allegation, saying he was an eye-witness to the Tappan Square portion of the incident.

"When you shoplift you get arrested. It doesn't matter what your sexual orientation is or your religion or your ethnicity. If yo shoplift, you get busted," he said.

While protesters were outside, James said he received many calls of support from longstanding customers.

Police drove slowly past the college students' protest several times but did not stop. Around 1 p.m., scanner traffic indicated they were taking a watchful stance and were prepared to respond if the event proved anything but peaceful.

Gibson's sues **Oberlin College**

OBERLIN — Gibson's Bakery has filed a lawsuit against Oberlin College, prompting the college to once again sever business ties with the downtown bakery.

The lawsuit lays out a narrative in which Oberlin College trying to recover its image of being supportive of the African-American community after firing a professor who is black, and with business interests in wanting to buy the Gibson property and adjacent parking lot — latched on to a shoplifting incident to promote Gibson's as a racist establishment to bolster its own image and interests.

It was filed Tuesday in Lorain County Common Pleas Court and names the college and Meredith Raimondo, vice president and dean of students, as defendants.

The complaint accuses the college of libel, slander, interference with business relationships, interference with contracts, deceptive trade practices, intentional infliction of emotional distress, negligent hiring and trespass and asks for more than \$200,000 in damages.

In a statement from the college, the college and Raimondo "deny and reject" all claims in the complaint and said the allegations "are untrue and we will vigorously defend against them."

"The college values its long relationship with the town of Oberlin and its businesses, including Gibson's bakery," the statement reads. "We are saddened that the Gibson family has chosen to pursue litigation. As this is now a legal matter, the college will suspend, effective immediately, its business relationship with Gibson's Bakery until such time as a mutually productive relationship may be re-established."

the college in November 2016 fired Joy Karega, an assistant professor of rhetoric and composition, for posting what the college considered to be anti-Semitic rhetoric.

In defense of Karega, students sent a 14-page list of demands, the complaint states, with one of those being that Karega, who is black, get comment on this matter.

The lawsuit details when Full statement from Oberlin College

Oberlin College and Dr. Raimondo deny and reject all claims asserted in the lawsuit filed by Gibson Bros., Inc. in the Lorain County Court of Common Pleas. The allegations are untrue and we will vigorously defend against them.

The College values its long relationship with the town of Oberlin and its businesses, including Gibson's Bakery. We are saddened that the Gibson family has chosen to pursue litigation. As this is now a legal matter, the College will suspend, effective immediately, its business relationships with Gibson's Bakery until such time as a mutually productive relationship may be reestablished.

We will have no further public

"guaranteed tenure."

Raimondo, who was special assistant to the president for diversity, equity and inclusion, was brought on to be vice president and dean of students "in an effort (for the college) to better market itself as a strong advocate for and a strong supporter of African-American students and racial minorities," the complaint states.

The firing of Karega and response from students, the complaint states, served as a backdrop for the incident on Nov. 9, 2016, wherein three college students who are black — Jonathan Aladin, Endia Lawrence and Cecelia Whettstone — were arrested after Aladin attempted to buy wine with a fake ID while also concealing two bottles of wine under his shirt.

When Allyn Gibson, who is white, confronted Aladin about the fake identification and attempted theft, Aladin ran out of the bakery, dropping the bottles of wine. Allyn Gibson pursued Aladin out of the store, and when police arrived, Allyn Gibson was on the ground with all three students punching and kicking him.

Days of protests followed the arrests, with chants and flyers spread around the community calling Gibson's "a racial establishment with a long account of racial profiling and discrimination."

Flyers were hung in college halls and urged students and staff to take business elsewhere.

The lawsuit alleges Raimondo and other college professors were present and took part in the protests and the dissemination of flyers as well.

In response to the accusations of racism, Oberlin police conducted an investigation into arrests at Gibson's and found "a complete lack of evidence of racism," the complaint states. In a five-year period, according to police, 40 adults were arrested for shoplifting and only six were African-American.

"The defendants consciously ignored the facts and findings of the Oberlin Police Department because such ignorance allowed them to continue their agenda against Gibson's bakery and the Gibsons," the complaint states.

According to the complaint, this agenda also includes wanting to buy the Gibson's building and the adjacent parking lot, owned by Allyn Gibson's father, David Gibson.

The complaint states the college encouraged staff and outside contractors to park in the lot, knowing it was meant to serve customers of surrounding business, including Gibson's Bakery.

Following the protests, Oberlin College canceled its longstanding order with Gibson's Bakery. At that time, David Gibson met with then-President Marvin Krislov and Tita Reed, assistant to the president of Oberlin College, during which time the college asked Gibson's not to push criminal charges against first-time shoplifters, according to the complaint.

The Gibson family, according to the lawsuit, said that would be "unworkable and unacceptable" and would only exacerbate the problem.

"Gibson's loses thousands of dollars a year due to stolen merchandise and such losses would certainly multiply if students learned they could steal without repercussion," the lawsuit states. "David Gibson believes the policy would be inconsistent with his core belief that an educational institution of higher learning should be teaching its students not to commit robbery and theft, instead of sheltering and excusing that criminal activity."

In August, Aladin, Lawrence and Whettstone pleaded guilty to amended misdemeanor charges in county Common Pleas Court. The deal called for them to receive no jail time and to pay restitution. Included in the deal was an admission by the three students that Allyn Gibson was within his right to detain Aladin and that his actions were not racially motivated.

Gibson's said in the lawsuit that the statement and guilty pleas did not stop the college from continuing to allege racial profiling.

The complaint states that Gibson's Bakery employees have been threatened and have had their tires punctured, the Gibsons' homes have been damaged and students who shop at the bakery have been threatened.

"The overall campus environment has resulted in a substantially reduced patronage by students, professors, administrators and other college constituents, as well as created a chilling effect upon persons that would normally support and patronize Gibson's Bakery," the complaint states.

Oberlin College sued by business over protests

An Oberlin business is suing <u>Oberlin College</u> and a vice president at the institution over student protests in 2016.

The suit was filed Nov. 7 in Lorain County Common Pleas Court on behalf of Gibson Bros. Inc., David R. Gibson and Allen W. Gibson.

Along with Oberlin College, Meredith Raimondo, vice president and dean of students, are named as defendants.

Oberlin College, however, denies any wrong doing.

The complaint arises from <u>protests some Oberlin College students held</u> in front of <u>Gibson's Food Mart and Bakery</u>, <u>23 W. College St.</u>, in November 2016 as a response to three of their classmates being arrested and charged with attempting to steal from the store.

Jonathan Aladin, 20, Cecelia Whettston, 19, and Endia Lawrence, 20, pleaded guilty in August to charges of attempted theft and aggravated trespassing. Aladin also pleaded guilty to underage purchase of alcohol.

Lorain County Common Pleas Judge James L. Miraldi placed the trio on one year of community control and ordered them to pay restitution to the store.

As part of the plea deal, they were required to read statements explicitly stating the incident was not racially motivated.

The suit alleges, despite the <u>Oberlin Police Department</u> releasing the incident report refuting the racial narrative, the college persisted in assisting students in protesting the store to bolster an attempt to brand the college as having a "legacy of being a strong advocate for and a strong supporter of African American students and racial minorities."

Aladin offered prosecutors to plead guilty to the charge of theft and Oberlin College was aware of that when a member of the board of trustees paid a retainer for an attorney to fight the charges and the college allegedly paid for a limo to take Aladin to Columbus and meet with the lawyer, the complaint says.

David Gibson felt pressure to approve a plea agreement in the case, the suit says.

However, Oberlin Municipal Court Judge Thomas A. Januzzi denied the agreement citing the seriousness of a second-degree felony robbery charge that was intended to be dropped in the deal, and the loss of money the bakery was undergoing due to protests by Oberlin College students, according to the suit.

The protests involved hundreds of students, deans, professors and college staff filling the sidewalks in front of the business and disseminating a flyer the suit identifies as libelous, the complaint says.

The flyer claims the business "is a racist establishment with a long account of racial profiling and discrimination," and urging customers to shop elsewhere, the suit says.

The flyer also identified 10 of the bakery's competitors again urging consumers to not patronize Gibson's, according to the suit.

The Oberlin Police Department investigated the claims of racism against the bakery and found that "of the 40 adults arrested for shoplifting at Gibson's Bakery in the past five years, only six were African American," the suits says.

According to the filing, the college publicly announced it would end any purchases from the bakery on Nov. 14, 2016. The colleges' director of dining services took a leave of absence and then early retirement after being ordered by Raimondo to cancel the contract.

According to the suit, Oberlin College has an interest in the bakery failing because it wants control of a parking lot adjacent to the business and owned by Off Street Parking Inc., of which David Gibson maintains the controlling interest in.

In a meeting between David Gibson and former Oberlin College President Marvin Krislov and another employee, Gibson shared the negative effect the college's and its students' actions were having on the business and the Gibson family, according to the suit.

Oberlin College represented it was open to re-initiating the contracts if the bakery would agree to "not push criminal charges against first-time shoplifters," the complaint says.

The college also insisted when a student is caught shoplifting, that the bakery call Raimondo rather than the police, the suit says.

Gibson refused, the filing says.

Contracts between the bakery and Oberlin College were reinstated in February 2017, but the school has refused to retract the defamatory statements and continues to defame the business, the suit claims.

As well as the economic sanctions against the business, the suit alleges David Gibson and Allyn Gibson have suffered "a severe emotional and physical toll."

According to the filing, the Gibsons are alleging Raimondo and Oberlin College committed libel, slander, tortious interference with business relationships, tortious interference with contracts, deceptive trade practices, intentional infliction of emotional distress, negligent hiring retention and supervision and trespass.

The suit requests an amount in excess of \$50,000.


In a Nov. 8 statement emailed to The Morning Journal, the college denies the claims.

"The allegations are untrue and we will vigorously defend against them," the statement read. "The College values its long relationship with the town of Oberlin and its businesses, including Gibson's Bakery.

"We are saddened that the Gibson family has chosen to pursue litigation. As this is now a legal matter, the College will suspend, effective immediately, its business relationships with Gibson's Bakery until such time as a mutually productive relationship may be re-established."

'End racial profiling' shouts OC crowd after arrests

"Hold Gibson's accountable" and "Gibson's is racist," chanted a throng c about 150 last Thursday outside the West College Street bakery.

Oberlin College students, bearing signs saying "No justice, no peace" and "End racial profiling," protested for hours and called for a boycott of the 131-year-old business.

While they took care not to block the entrance, they did hurl expletives a

the few customers who entered.

"This is a racist establishment with a long account of racial profiling and discrimination," said literature written by students and provided to the News-Tribune by dean of students Meredith Raimondo.

She and other college administrators stood by to monitor the protest, said Scott Wargo, OC director of media relations.

The single-page leaflet alleged bakery owner Allyn Gibson choked a 19-year-old man until others forced him to let go. The account claimed Gibson chased the man across College Street and onto Tappan Square, tackling and restraining him until police arrived.

It said the alleged victim and two friends were racially profiled at the scene but did not explain how. Police arrested the three but did not read them their rights, students claimed.

Jonathan Aladin, 19, was charged with robbery, a second-degree felony. He was arraigned in Oberlin Municipal Court but did not enter a plea, and was released on \$5,000 bond.

An Oberlin police report gives a much different version of events than the students' leaflet.

Two reporting officers said they arrived to find Gibson "lying on his back with several individuals kneeling over him," punching and kicking him.

When those officers tried to intervene, they were met with resistance from several people, the report said.

Store employees said Jonathan Aladin attempted to conceal to bottles of wine under his shirt. When Gibson tried to take a picture of Aladin, the latter slapped Gibson's hand and phone, which struck the store owner in the face, according to the report.

This account says Aladin ran to the back of the store and threw the wine on the floor, and when cornered he grabbed and hit Gibson, finally fleeing the bakery with two women. Gibson pursued.

Across the street, Gibson said he was again attacked and the women joined in. At one point, Aladin threatened to kill him, Gibson told police.

Officers noted Gibson had a swollen lip, abrasions to his arms and wrists, and a small cut on his neck.

The women allegedly involved in the attack were identified by police as Endia Lawrence, 19, and Cecelia Whettstone, 18. They were both charged with assault and pleaded not guilty in their initial court appearances.

The report also said Gibson turned over a fake South Carolina ID card and credit card in Aladin's name.

"When you shoplift you get arrested. It doesn't matter what your sexual orientation is or your religion or your ethnicity. If yo shoplift, you get busted," said Trey James, a worker at Gibson's.

Thefts from the store have been on the increase lately, according to James.

While protesters were outside, James said he received many calls of support from longstanding customers.

Police drove slowly past the college students' protest several times but did not stop. Around 1 p.m. Thursday, scanner traffic indicated they were taking a watchful stance and were prepared to respond if the event proved anything but peaceful

Protesters returned Friday, their numbers growing and shrinking throughout the day and moving first away from Gibson's doors and finally across the street.

A counter-protest rolled out Saturday as supporters of the bakery rallied. A "cash mob" flooded the area with cars and motorcycles, lining up to spend money on coffee and doughnuts.


A Facebook page also briefly sprang up to support Gibsons but just as quickly disappeared. It called on people to exercise their Second Amendment rights to "protect" the bakery.

Gibson's Bakery struggling after loss of Oberlin College business, owner says

OBERLIN — David Gibson says he hasn't been able to pay himself since the shoplifting incident last year prompted Oberlin College to stop buying from the eponymously named bakery.

When asked if the bakery could continue to maintain its same hours, Gibson said he's not sure.

"We've got a lot of decisions to make and we're going to have to see how this goes," Gibson said. "I can tell you that I haven't taken a paycheck since this has happened. I've been working on just trying to keep the business alive."

Gibson sued the college this week, asking for more than \$200,000 in damages and accusing the college and its vice president, Meredith Raimondo, of libel and slander and interfering with the bakery's business contracts.

The lawsuit reignites a rift between the bakery and the college that began last year when a student tried to buy alcohol with a fake ID while also concealing two bottles of wine under his shirt from Allyn Gibson, David Gibson's son.

The incident became racially charged because Allyn Gibson is white while the student and two others also charged in the incident are black. All three students pleaded guilty in August to misdemeanor charges and read statements into the record acknowledging that Allyn Gibson was within his right to detain the shoplifter and that his actions were not racially motivated.

By that time, however, the damage had been done, Gibson said.

According to the lawsuit, flyers advising students and residents not to shop at Gibson's were handed out during protests in front of the bakery and pinned to announcement boards in college buildings.

On Wednesday, a group called Totally Engaged Americans of Lorain County gathered at the business in support. Some held signs saying "Oberlin College Supported Criminals" and "I support Gibson's."

"We're here to support Gibson's bakery ... because it seems like Oberlin College is not interested in supporting Gibson's," said Kirsten Penton Hill, the director of Totally Engaged Americans.

"From the articles it seems like Oberlin College is being a bully and are suggesting Gibson's report thieves to them before they report them to the Police Department. Well how is Gibson's going to determine who's a college student and who's not?"

Don Killinger, a Lorain resident and a member of the group, said it was his first time at Gibson's. He said he came to support the bakery's effort to stay open.

"They have a right to stand for what is right and not allow shoplifting to occur in their store," Killinger said.

David Gibson said any support helps, but losing the college's business has been a severe blow.

"I've always been proud of Oberlin, my community, and we've worked our lives — my father and myself — to try to make Oberlin a good place to live and to do business," David Gibson said. "Has it been stressful? It's extremely stressful on my family and my employees."

The number of employees "is down considerably" David Gibson said, and the bakery is making significantly fewer products.

David Gibson would not comment as to whether other businesses surrounding the bakery are affected.

"It just got to the point where we didn't feel like we'd gotten our name back and that we just didn't want to have us as individuals and our business and the community afraid to live and work here," David Gibson said.


"We just do our best to be positive. I would hope eventually we could get through this and bring the community together. It's been a very difficult time."
