#### ORDER DIRECTING THE PARTIES TO FILE SUPPLEMENTAL BRIEFS

On August 2, 2023, the Board issued its decision in *Stericycle, Inc.*, 372 NLRB No. 113 (2023), which overruled *Boeing Co.*, 365 NLRB No. 154 (2017) and its progeny, and established a revised analytical framework in cases involving Employer rules and their potential impact on employee protected activity. In light of this ruling, I direct the parties to submit supplemental briefs discussing how this ruling impacts the issues in the present case. Additionally, on June 30, 2023, the Supreme Court issued its ruling in *303 Creative LLC v. Elenis*, No. 21—476 (U.S. June 30, 2023), which may impact Respondent's First Amendment rights regarding what is wishes to communicate or convey on its uniforms or through its dress policy. Accordingly, the parties are also directed to address this issue in their supplemental briefs.

The briefs should be submitted by <u>close of business August 21, 2023</u>, and should be limited to no more than 15 pages.
