Dear Dr. Brown:

This constitutes the administrative appeal of the Equal Protection Project (EPP) of the Legal Insurrection Foundation regarding EPP's FOIL Request dated May 28, 2024 (attached)(the "FOIL Request") and the response of the Ithaca City School District (ICSD) dated July 3, 2024 (attached).

Request No. 6 requested:

6. Communications with the Office for Civil Rights of the U.S. Department of Education, regarding the complaint (https://defendinged.org/wp-content/uploads/2023/03/Ithaca-City-School-District-OCR-Complaint_Redacted2.pdf) of Parents Defending Education (Case 02-23-1241), including but not limited to such communications with OCR as set forth in whole or in part the representations reflected in OCR's letter dated September 7, 2023 (https://defendinged.org/wp-content/uploads/2023/09/02-23-1241-Ithaca-City-SD Redacted.pdf):

"The District informed OCR that the affinity groups listed on the announcement and scheduled for February 8, 2023, did not take place. The District further informed OCR that all of the District's programming is open to all participants regardless of race and there are no affinity groups or other programs that are exclusionary based on race."

In response, ICSD has not produced any records responsive to Request No. 6, and ICSD does not list Request No. 6 as a request as to which it is in possession of records. ("Following a diligent search, we have determined that the District is in possession of records responsive to your requests 1, 2, 3, 4, 5, 7, 8, and 9). Such records undoubtedly exist, likely at ICSD's legal counsel. If the records are in the possession of ICSD's legal counsel who interacted with OCR, they are still ICSD records that must be produced pursuant to the FOIL Request. Since no exemptions are claimed as to these records, please produce them immediately.

All Other Requests: Excessive Redactions

As to all other Requests (1-5, 7-9) ICSD has produced heavily redacted records without any explanation on a record-by-record basis as to which exemption is claimed or on what basis.

As indicated in the FOIL Request, EPP did not seek personally identifiable information as to ICSD students, but the redactions appear to go far beyond protecting such information. Instead, ICSD asserts omnibus boilerplate, non-specific, exemption claims:

"Under FOIL, while there is a presumption of access to governmental records, certain exceptions exist that allow the entity to withhold records in whole, or in part. The Family Educational Rights and Privacy Act ("FERPA") protects student information and places certain restrictions on school districts with regard to disclosure without parental consent. Pursuant to FERPA and Education Law Section 2-d, any and all student information, including any identifying information have been redacted from these records. Other records were redacted in whole or in part, pursuant to the intra-agency communications exception to FOIL. Finally, other records were redacted in whole or in part, as such disclosure would constitute an unwarranted invasion of personal privacy"

Because ICSD chose not to specify which exemptions it is claiming as to which redacted records, we are unable to address ICSD purported claim of exemption on a record-by-records basis. Since ICSD made omnibus claims of exemption, we appeal from and contest such redactions and demand that ICSD produce the records without redaction except for personally identifiable student information.

Additionally, ICSD chose not to number stamp its records production. Accordingly, attached hereto is a representative sample of records produced by ICSD, which we have stamped "ICSD - Equal Protection Project FOIL - Contested Redactions - 00001-133, as to which we contest the

claim of exemption and redactions. To assist you in locating the records so that you can produce them unredacted, here are the file names contained in the numbered set.

There is nothing on the face of these documents, as redacted, that indicates any exemptions apply or as to which redaction is justified (other than student personally identifiable information, which we do not contest).

Since this matter may end up in court, please provide specific justifications for each redaction. ICSD simply restating the statutory basis for refusing disclosure without factual evidence is not sufficient. And it's not likely that the records contain the types of information comprising an unwarranted invasion of privacy described in section 89(2)(b) of FOIL, or any similar information of an intimate or personal nature that is not already subject to redaction under FERPA.

Conclusion

We hereby demand that ICSD (1) immediately produce the records called for by Request No. 6, as to which no exemptions are claimed, and (2) produce all the records, including but not limited to those marked "EPP Appeal ICSD Redacted Records 00001-00000", without redaction except as to student personally identifiable information.
